The Clerk has received brochures from Balfour Beatty advising landowners on ditches hedges and footpaths.

BOATS maintenance. D Williams and M Jenkins continue to liaise with Balfour Beatty and specific roads requiring attention have been reported to this agency.

Red Telephone Boxes. S Lowthian reported that solar panels to these units could cost up to £500 per Telephone Box. It is questionable if they would be successful due to poor lighting restraints. R Smith reported that a regular supply of books could be made available as a potential use for a Telephone Box.

Website. Development continues with input from G Litson and maintenance from R Smith.
