

## **Footpath Officer's Report 9<sup>th</sup> February 2017**

### **Reports from the Public**

Report received regarding condition of PROWs WC99, WC100, WC102, WC107, GN6 and GN14. A number of missing fingerposts have been identified. WC100 needs clearing again in the vicinity of Bourne House.

WC68 was closed for a few days by Balfour Beatty in order for them to reinstate a broken balustrade. It has since been reopened.

WC110. The parish has been formally notified of a modification order to reinstate footpath WC110 which runs from Meeks Well Lane along the side of the property known as Rowan House, to Ashes Lane. Balfour Beatty are responsible for ensuring that the path is reinstated.

### **Ongoing issues**

WC75 is still blocked by fallen trees. The Lengthsman's team has been badly hit by the ongoing Man-flu epidemic and this has seriously curtailed the work they were scheduled to do.

WC87. This footpath runs from the C1257 at the top of The Paddocks drive, across the flood meadow to meet with WC1. There is no finger post at the junction with the C1257, and no way marker post at the junction with WC87. In fact there is no sign of WC87 at all. It seems to have disappeared.

#### **Lengthsman Report**

Report received on replacing signage

#### **Status of paths**

The following paths are blocked:

WC47 - Blocked at Rockleech  
WC54 - Blocked from junction with WC57 down to Sandiway Lane  
WC55 - Blocked from Sandiway Lane by wooden / wire fence and 6ft hedge.  
WC87 – has 'disappeared' and needs to be reinstated.  
WC95 - Blocked by hedgerow at junction with lane opposite Tuck Mill.  
WC96 - Blocked by domestic fence  
WC101. Blocked near Daf-y-Nant House.

The following paths are passable but require maintenance:

GN1 - Fence falling across path and encroaching undergrowth by Kennel Cottage

GN5 - Partially blocked by fallen tree near junction with lane near Sellarsbrook Park  
GN9 - Stile needs repairing/replacing  
WC1 - Overgrown between Leisure Park and Ferrie Inn  
WC37 – Overgrown below May Cottage  
WC34 – Overgrown and impassible for much of its length.  
WC46 - Electric fence across stile  
WC50 - Badly eroded in places  
WC52 - Overgrown and impassible for much of its length.  
WC68 - In places the wooden steps have broken and need to be replaced  
WC75 – Blocked by fallen beech tree behind Rambler Cottage  
WC102 - From the U71230 road access footbridge the first stock fence has no stile.
